US CPA Exam

The Uniform CPA examination is conducted by the AICPA (American Institute of Certified Public Accountants) which is the world's largest accounting body. AICPA offers membership to all candidates who successfully clear the CPA exams.

CPA Canada - MRA with US CPA

US CPA's can directly earn CPA Canada without any additional exam. This is significantly different from the ICAI - CPA Canada MRA which requires CA's to pass the CFE (Common Final Examinations) which is a 3 day examination and requires candidates to be in Canada to appear for the same.

Canada's accounting profession of 200K+ members is represented by a single national body - **CPA Canada**.

- Earlier, there were 3 accounting qualifications in Canada:
 - CA (Chartered Accountant), CGA (Certified General Accountant) & CMA (Certified Management Accountant).
- In 2013, all these 3 qualifications were merged to form the new designation - **CPA Canada**.

MRA (Mutual Recognition Agreement) effective Jan 2018 - between:

- All Canadian CPA bodies, NASBA and AICPA - represented by IQAB.

No additional exam for US CPAs to earn Canada CPA.

Eligibility:

- Active US CPA license (and in compliance with required CPE).
(Note: Need to pass all 4 parts of the US CPA exam before becoming a resident of Canada)*
- Education - 150 credits
- Experience - 24-30 months of relevant experience
